Just mail or fax credentials with list of names and appropriate fees to Parker Trade Shows. Read on for fees and instructions.

## Registering at the Show:

Buyers are required to present Driver's License, industry-related tax I.D. and business card or company check. Non-industry-related companies **MUST** show wholesale invoices totaling \$500 or more.

## Pre-Registration: (Pre-Registration fees are the same as at the show)

Mail or Fax your Tax I.D. and a business card or company check, along with badge fee, to our office. If you are a Non-industry-related company, send \$500 of wholesale invoices with your company credentials. Badges are mailed to you within 48 hours.

## 2 Year Badges:

To buy a 2-year badge, bring the above-mentioned credentials to the show. 2-year badges are \$25.

## Become a VIP Buyer:

To become a VIP Buyer, you must show \$10,000 of wholesale invoices dated within a 12-month period. VIP Buyers are mailed their preprinted badges before each show, and are given access to the VIP lounge. This program is designed for the Tax I.D. Holder and Spouse only.
